EXCLUDE IGG EVIDENCE

COMES NOW the State of Idaho, by and through the Latah County Prosecuting Attorney, and submits the following reply to the March 17, 2025 "Defendant's Reply to State's Opposition [sic] to Motion in Limine 11 RE: Exclude IGG Evidence."

The State will be meeting with its prosecution and investigation team to identify who will testify about the receipt of a "tip" on or about December 19, 2022, and the subsequent actions taken by investigators and the State, and advise Court and Counsel.

It is unclear what the Defendant means in the last sentence of his reply: "since this

testimony will be sanitized for presentation to the jury to avoid the IGG process, it must also not falsely suggest that there was any other evidence or tip that led the State to Mr. Kohberger.”

There is substantial evidence (gathered both prior to the “tip” and subsequently) leading to Mr. Kohberger being the person responsible for the November 13, 2022, homicides and burglary.

The State will certainly not “falsely” produce or refer to this other evidence but will rely on all of this evidence at trial to establish the Defendant’s guilt.
