**ORDER GRANTING INDEPENDENT ANALYSIS OF EVIDENCE** *Defense Brief*

The Court having before it the *Motion for Independent Analysis of Evidence*, and good cause appearing, now, therefore;

IT IS HEREBY ORDERED that the aforementioned evidence shall be made available to defense expert, [REDACTED] by the Moscow Police Department and/or other agency in possession of the same, for independent testing and review by an independent testing agency.


IT IS FURTHER ORDERED that [REDACTED] shall, at the defense counsel's expense, be allowed to conduct the independent testing of the evidence. Specifically, the Acer Laptop and Samsung phone belonging to Bryan Kohberger.

IT IS FURTHER ORDERED that the chain of custody shall be maintained on the evidence at all times. Moscow Police Department shall hand-deliver and/or ship the evidence via FedEx directly to [REDACTED] who will ship the evidence via FedEx back to the Moscow Police Department upon completion of testing. The evidence should be shipped to attention [REDACTED].

IT IS FURTHER ORDERED that upon completion of testing by [REDACTED] [REDACTED] is to immediately notify Anne C. Taylor to arrange for transfer of the evidence back to the Moscow Police Department.

IT IS FURTHER ORDERED that the results of the testing shall be considered work product of Mr. Kohberger and/or his attorney and said results shall be submitted solely to the office of Anne C. Taylor.
