On May 1, 2023, a coalition of 20 media outlets<sup>1</sup> (“Associated Press”) filed a Motion to Intervene and a Motion to Vacate the Amended Nondissemination Order. In opposition to the Motion to Vacate the Amended Nondissemination Order, Defendant Bryan C. Kohberger filed a Motion to Take Judicial Notice of Press Coverage.




