**AMENDED ORDER FOR DISCLOSURE  
OF IGG INFORMATION AND  
PROTECTION ORDER**


Based on the February 28, 2024, hearing, the Sealed Order for Disclosure of IGG Information and Protection Order is amended as follows:

Defense counsel (Anne Taylor, Jay Logsdon, and Elisa Massoth), Defendant (Bryan Kohberger), and IGG defense experts (Dr. Leah Larkin, Bicka Barlow, and Steven Mercer) may view the IGG materials provided by the State. Any further dissemination of the materials or the information contained within the materials, including to any investigators, must first be approved by the Court after a showing by the defense as to why such individual needs the information for the preparation of the defense.

Additionally, no individual on the family tree who was not previously known to the defense via the defense’s own investigation may be contacted by the defense or any agent of the defense without prior authorization from the Court after a showing as to why such contact is necessary and material to the preparation of the defense.

The defense's mitigation expert, who has created her own family tree and who does not have access to any of the IGG information, may continue her mitigation investigation, including contacting Defendant's immediate family members and other related individuals.
