The Honorable Brian D. Lee presided. The State was represented by Payette County Prosecutor Mike Duke. The Defendant appeared in person and through counsel, Anthony Ray Geddes; Isaiah Lee Govia; Abby King Broyles.

The Court reviewed the evidence and testimony and concluded that there is substantial evidence that the public offense(s) listed above was/were committed in Payette County and found probable cause to believe the Defendant committed said offense(s).

IT IS THEREFORE ORDERED that the Defendant be bound over to the District Court and held to answer to the charge(s) listed above.

Bond status: The Defendant's Bail is \$Hold Without Bond. The Defendant is remanded to the custody of the sheriff.


The Court ORDERED the Defendant to stay in contact with his/her attorney and attend all future court proceedings.
