Pursuant to Idaho Criminal Rule 7, the Prosecuting Attorney for the County of Payette, Idaho, alleges by this information that:

STACEY JAMES WONDRA, has perpetrated one or more crime(s) against the State of Idaho, to-wit:

COUNT I - PART I - MURDER IN THE FIRST DEGREE, I.C. 18-4001, 4002, 4003, (FELONY)

COUNT II – PART I - KIDNAPPING IN THE SECOND DEGREE, I.C. 18-4501; 18-4502; 18-4503, (FELONY)

COUNT III – PART I - DESTRUCTION AND/OR ALTERATION AND/OR CONCEALMENT OF EVIDENCE, I.C. 18-2603, (FELONY), said crimes being committed as follows:

COUNT 1: That the Defendant, **STACEY JAMES WONDRA**, on or about the 27th day of July, 2021, in the County of Payette, State of Idaho, did in the perpetration of or attempt to perpetrate a kidnapping, kill and murder M.V., a human being, which is a violation of I.C. 18-4001, 18-4002, 18-4003 ~ **MURDER IN THE FIRST DEGREE, (FELONY)**.

COUNT 2: That the Defendant, **STACEY JAMES WONDRA**, on or about the 27th day of July, 2021, in the County of Payette, State of Idaho, did willfully and without lawful authority seize and/or confine, and/or lead and/or take and/or entice away M.V., with the intent to cause him to be secretly confined an/or imprisoned and/or detained against his will within the State of Idaho, which is a violation of **I.C. 18-4501; 18-4502; 18-4503 ~ KIDNAPPING IN THE SECOND DEGREE, (FELONY).**

COUNT 3: That the Defendant, **STACEY JAMES WONDRA**, on or between the 27th day of July, 2021, and the 21st day of May, 2025, in the County of Payette, State of Idaho, did willfully destroy and/or alter and/or conceal a thing, to-wit: a body and/or DNA evidence and/or a vehicle and/or furniture, and/or phones and/or SIM card and/or computer evidence and/or phone evidence and/or digital and/or electronic evidence, knowing that the thing or things were about to be produced, used or discovered as evidence in a felony investigation or inquiry authorized by law, and with the intent to prevent such evidence from being so produced, used or discovered, which is in violation of **I.C. 18-2603 ~ DUSTRUCTION AND/OR ALTERATION AND/OR CONCEALMENT OF EVIDENCE, (FELONY).**


