Pursuant to the Scheduling Order issued by the Court on November 15, 2021 in *Durst v. Idaho Commission for Reapportionment*, Supreme Court docket number 49231-2021, which ordered the Commission to prepare and transmit “the record of proceedings leading up to and including the final report adopting Plan L03,” and the Scheduling Order issued by the Court on December 17, 2021 in this matter making the record of proceedings filed in *Durst v. Idaho Commission for Reapportionment*, Dkt. 49261-2021 part of the record in this proceeding, Respondents hereby transmit by thumb drive to the Idaho Supreme Court a supplemental record of proceedings leading up to and including the final report adopting Plan C03.

This transmittal is specific to the congressional plans considered by the Commission. Supplementation of the record provided in the *Durst v. Idaho Commission for Reapportionment* matter is necessary given that that challenge, and the challenges consolidated with it, are specific to the legislative redistricting plan adopted by the Commission. This challenge addresses the congressional redistricting plan adopted by the Commission and therefore encompasses a different set of documents.
