**ORDER**


to close and seal the

On Friday, September 30, 2022, the Court received an *Ex Parte Affidavit*. Upon review of its contents, the Court called an exigent hearing on the record with Counsel for the State and Counsel for the Defendant present, for the limited purpose of authorizing the dissemination of the *Ex Parte Affidavit* to all Parties, under seal. The Court thereafter, on shortened time, held a closed hearing on October 5, 2022, to discuss with all parties future proceedings relating to the Defendant's fitness to proceed to trial.

Pursuant to I.C.A.R. 32 the Court finds that both the *Ex Parte Affidavit* and the October 5, 2022 closed hearing reference information that is expressly exempt from public disclosure. See I.C.A.R. 32(g)(10). Accordingly, the Court determines the closure and sealing is necessary to protect individual privacy rights and interests, and to preserve the Parties' rights to a fair trial, and such action is no broader than necessary to protect this fundamental right.
