**ORDER**

On May 24, 2021 a Grand Jury in Fremont County returned a true bill of indictment charging both Chad Guy Daybell and Lori Norene Vallow Daybell on one indictment, as provided for in Idaho Criminal Rule 8(b). Upon consideration of issues raised by counsel regarding the Defendants' case numbers and administrative proceedings in the cases, the Court issues the following order.

For purposes of conducting a jury trial, the cases of State of Idaho v. Chad Guy Daybell, CR22-21-1623; and State of Idaho v. Lori Norene Vallow Daybell, CR22-21-1624; are currently joined.<sup>1</sup> However, for administrative purposes, and in order to protect Defendants' full panoply of rights, including due process protections, afforded by the United States Constitution and the Idaho State Constitution, each Defendant has a unique case and unique case number.

It is therefore ordered and confirmed that Fremont County Case No. CR22-21-1623, State v. Chad Guy Daybell; and Case No. CR22-21-1624, State v. Lori Noreen Vallow Daybell; are two separate cases before the District Court in Fremont County, Idaho, regardless of the single indictment. The defendants are however joined for purposes of trial, pursuant to I.C.R. 8(b).
