Amended Order Reducing Bail and
Conditions of Release

Bail is set in the amount of \$1,000,000.00. The Defendant is ordered, as a condition of bail and/ or release, to comply with the following:

1. The defendant must sign a Waiver of Extradition provided by the Madison County Office of the Sheriff. The prosecutor must approve the Waiver of Extradition by his signature on the Waiver of Extradition. A copy of the Waiver of Extradition must then be filed with the Court.
2. The defendant shall reside within the boundaries of Bonneville, Jefferson, Madison and Fremont counties in the state of Idaho. The defendant shall not leave this four county area for any reason.
3. The defendant must wear an ankle monitor 24 hours a day, 7 days a week. She must have the ankle monitor in place before she is released from Madison County jail. Any violations of the geographical limitations imposed herein must be reported immediately to the Madison County Sherriff's Office and the Court.
4. The defendant must appear for all court appearances and maintain contact with her counsel.
5. The defendant must abide by all laws.
6. The defendant shall provide to the Court under seal the address at which she shall reside.

The defendant is hereby notified that, while under the order to wear an ankle monitor, intentionally leaving the area of restriction, except for the purpose of obtaining emergency medical care, may be prosecuted as the crime of escape and subject the defendant to the penalties in Idaho Code Section 18-2505 or Idaho Code Section 18-2506. Idaho Criminal Rule 469(e)(3).

If the defendant fails to comply with any of these terms the Court may, pursuant to Idaho Criminal Rule 46(i) and Idaho Code Section 19-2919, revoke the defendant's release and issue a warrant for the defendant's arrest.
